

Article 1 - KECA INTERNATIONAL PRODUCT WARRANTY

- 1.1 Keca International Inc warrants that each item, at time of delivery to buyer are hereby specifically disclaimed in particular, but without limiting to the foregoing exclusions:
- (i) if the items are made according to buyer's specifications, Keca International Inc does not warrant adequacy of such specifications or that the items will perform in accordance with set specifications;
 - (ii) if any items supplied in Article 1.2 are made by any supplier other than Keca International Inc, no warranty will be provided by Keca International Inc with respect to such items;
 - (iii) Keca International Inc does not warrant that the items are in compliance with the laws of any country
- 1.2 Keca International Inc product warranty will be applicable to the following items:
- Wood chairs and wood barstools:** One (1) year free from defects and workmanship.
 - Metal chairs and metal barstools:** One (1) year free from defects and workmanship.
 - Soft seating:** One (1) year free from defects and workmanship.
 - Wood table tops:** One (1) year free from defects and workmanship.
 - Fabric:** Subject to warranty of the textile company
 - Laminate table tops:** Subject to the warranty of the laminate company
 - Table bases:** Subject to the warranty of the table base company
- 1.3 Keca International Inc's sole obligation under the foregoing warranties will be limited to either, at Keca International Inc's option, replacing or repairing defective items or refunding the purchase price paid for such items previously paid by buyer, and buyer's exclusive remedy for breach of any of such warranties will be enforcement of such obligation of Keca International Inc.
- 1.4 These warranties are not extended to items subjected to misuse, neglect, damage, accident or improper installation/maintenance, or which have been altered or repaired by anyone other than Keca International Inc or its authorized representative. Keca International Inc shall not be liable to any claim for defective items, which is not made within thirty (30) days after discovery with a written report of defect.
- 1.5 Keca International shall not be held responsible for table top defects caused by exposure to installation areas with a moisture content outside of the 12-14% range.

Article 2- REMEDIES AND LIMITATION OF LIABILITY

- 2.1 No items may be returned without Keca International Inc's written consent.
- 2.2 Keca International Inc reserves the right to inspect any claimed defect, repair defective items or install replacement parts, and perform any adjustments to satisfactory operation of the items.
- 2.3 In no event shall Keca International Inc be liable for incidental, consequential or special damages, including without limitation, lost revenues, profits or recall expenses, nor shall Keca International Inc's liability on any claim for damages arising out of or connected with the contract or the manufacture, sale, delivery or use of the items exceed the purchase price and shipping costs of the items previously paid by buyer to Keca International Inc.
